

## **ORDINANCE NO. 2021-05-24**

### **ANNUAL APPROPRIATION ORDINANCE FOR THE VILLAGE OF SHABBONA FOR THE FISCAL YEAR 2021-2022**

An Ordinance making appropriation for the corporate purposes for the Village of Shabbona, DeKalb County, Illinois, for the fiscal year A.D. 2021-2022.

Be it ordained by the Board of Trustees of the Village of Shabbona, DeKalb County, Illinois:

SECTION 1: That for the purposes of paying the corporation expenses of the Village of Shabbona, DeKalb County, Illinois, and in addition thereto, for the Public Library in the Village of Shabbona for the fiscal year 2021-2022, the following sums of money are appropriated for the following purposes and objects, to-wit:

SECTION 2: In addition to the foregoing appropriations, the income, revenue and monies derived and collected from the operation of the water department of said Village, by said Village are hereby appropriated for the payment of the expenses of such operation and for repair and for the construction of additions and improvements to the water supply system of said Village.

And in addition thereto, all the money received from the Village's share of the road and bridge tax collection on a property within the limits of said Village is hereby appropriated for the payment of the expenses of the care and maintenance of the streets and alleys of the Village of Shabbona.

And in addition thereto, all the money received from the Municipal Retailer's Occupation Tax is hereby appropriated for the general corporate purposes of said Village of Shabbona.

And in addition thereto, all the money received from the State of Illinois as the Village's share of the Illinois State Income Tax and Illinois State Replacement Tax is hereby appropriated for the general corporate purposes of said Village of Shabbona.


And in addition thereto, all monies received from garbage tax, garbage bills, fines, licenses, interest, utility taxes, and cable TV payments are hereby appropriated for the general corporate purposes of the Village of Shabbona.

SECTION 3: The said several sums of money are hereby appropriated from monies received and to be received by the Village of Shabbona from all sources.

SECTION 4: All unexpended balances of items of any general appropriation made by this Ordinance may be expended in making up the deficiency of any item or items of the same general appropriation or in like appropriation made under this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


